AN ORDINANCE AMENDING PAY
CLASSIFICATION ORDINANCE NO. 09-2008 BY
PROVIDING NEW PAY CLASSIFICATIONS
FOR THE OFFICE PERSONNEL, PUBLIC
WORKS PERSONNEL AND THE VARIOUS
CITY BOARDS

BE IT HEREBY ORDAINED BY THE CITY OF HIGHLAND HEIGHTS, KENTUCKY AS
FOLLOWS:

Section I

That a new pay classification, attached hereto and incorporated herein, is adopted for the
office personnel, public works personnel and all city boards.

Section II
