ORDINANCE NO. 10-2014

AN ORDINANCE ESTABLISHING A PAY CLASSIFICATION ORDINANCE BY PROVIDING NEW PAY CLASSIFICATIONS FOR THE POLICE DEPARTMENT, THE OFFICE PERSONNEL, PUBLIC WORKS PERSONNEL AND THE VARIOUS CITY BOARDS AND REPEALING ORDINANCE NO. 09-2008.

BE IT HEREBY ORDAINED BY THE CITY OF HIGHLAND HEIGHTS, KENTUCKY AS FOLLOWS:

Section I

That a new pay classification, attached hereto and incorporated herein, is adopted for the police department, office personnel, public works personnel and all city boards.

Section II


That ordinance number 09-2008 is hereby repealed.
