ORDINANCE NO. 10-2005

AN ORDINANCE ENACTING AND
ADOPTING A SUPPLEMENT TO THE
CODE OF ORDINANCES OF THE
CITY OF HIGHLAND HEIGHTS,
KENTUCKY.

WHEREAS, American Legal Publishing Corporation of Cincinnati, Ohio has completed the 2005 supplement to the Code of Ordinances of the City of Highland Heights, which supplement contains all ordinances of a general nature enacted since the prior supplement to the Code of Ordinances of this municipality; and

WHEREAS, American Legal Publishing Corporation has recommended the revision or addition of certain sections of the Code of Ordinances which are based on or make references to sections of the Kentucky Revised Statutes;

WHEREAS, it is the intent of Council to accept these updated sections in accordance with the changes of the law of the Commonwealth of Kentucky;

NOW THEREFORE, BE IT ORDAINED BY THE CITY OF HIGHLAND HEIGHTS, KENTUCKY AS FOLLOWS:

Section I

That the 2005 supplement to the Code of Ordinances of the City of Highland Heights, Kentucky, as submitted by American Legal Publishing Corporation of Cincinnati, and as attached hereto, be and the same is hereby adopted by reference as if set out in its entirety.

Section II

That this ordinance shall take effect and be in force from and after its date of passage, approval and publication as required by law.

Section III


That this ordinance shall be signed by the Mayor, attested by the City Clerk/Treasurer, recorded and published according to law. Same shall be in effect at the earliest time provided by law.

Second reading on this 19 day of July 2005.

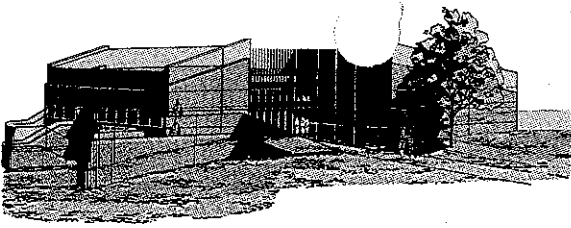

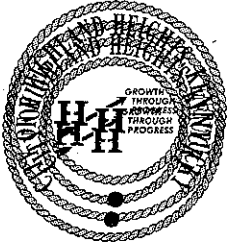
