- Resolution #01-2022: A resolution supporting expenditure of Coronavirus State and Local Fiscal Recovery Funds (SLFRF), from the American Rescue Plan Act funds (ARPA), for the purpose of premium pay for eligible workers performing essential work during the COVID-19 public health emergency.

- Ordinance #02-2022: An ordinance amending the text of Ordinance #16-83 commonly referred to as the City of Highland Heights Zoning Ordinance section 9.21 regulations pertaining to remove the text that allows the zoning administrator to review plans for parking in residential zones when it exceeds 25% of the front yard area as section 9.21.G places the authority with the Board of Adjustment.

- Attorney Franzen shared his opinion of the of the quality and service of the Highland Heights Police Department. He also discussed his thoughts on the importance of the police officers, the challenges of their work, and what can be done to recruit and retain officers.



S.I.R.T. SPECIAL INVESTIGATIONS RESPONSE TEAM

Monthly meeting on 01/19/22.

Presentation by Detective McGohan on what would be expected on a collision reconstruction scene. Several new members were added to the team from Fort Thomas Police. These members were provided with FARO instructions and provided with a brief overview of what is expected during a call out.

01/30/22 SIRT activated to assist Fort Thomas Police with several scenes in Fort Thomas and Newport. During a vehicle pursuit of a suspected intoxicated driver shots were fired at officers. The driver fired a 9 mm handgun through the windshield of the car he was driving at Fort Thomas Officers. The driver crashed at the Grand/Carothers intersection and was captured after a short foot pursuit.

SIRT members documented the scenes with photographs and FARO scans. Evidence was collected and turned over to FTPD.

01/31/22 SIRT assisted FTPD with search warrant of the vehicle. Photographs and FARO scans taken. SIRT reconstructed the flight path of the rounds fired at officers to show that the driver had intent to injure the officers. The trajectory path showed the rounds were fired from just above the steering wheel at the officers. A final report will be completed.

CITY OF HIGHLAND HEIGHTS CITY ENGINEER/ZONING ADMINISTRATOR REPORT

February 2, 2022

ZONING CODE ENFORCEMENT – The majority of Zoning Violations have been corrected and there are only a few currently in process. I have sent letters to the property owners letting them know that enforcement will be postponed while the cold/snow/ice makes it difficult to correct the violations – enforcement action will however resume when the weather conditions improve.

ZONING ORDINANANCE TEXT AMMENDMENTS – SECITON 9.21 & 12.0.C.1.a - The Planning Commission held a public hearing on proposed amendments to the Zoning Ordinance on 1/11/22, and voted to forward the amendments to City Council for adoption.

The proposed changes to Section 9.21 are intended to:

- Reinforce that campers/RV's are not to be used as dwellings. (We discovered that an RV on Thompson Avenue has been occupied for 3 years).
- Extend the requirement for all vehicles to be licensed/insured/operable to all zones not just the residential zones.
- Extend the limitation on where and how many campers/boats/RV's can be stored in all zones –
 not just residential zones. (An effort to keep parking lots from becoming storage lots).
- Prohibit the installation of skirting and decks on campers/RV's and prohibit them from being connected to utility service (water,gas,septic).

The proposed change to Section 12.0.C.1.a are proposed to remove the text that allows the Zoning Administrator to review plans for parking in residential zones when it exceeds 25% of the front yard area – as this is in conflict with Section 9.21.G that places that authority with the Board of Adjustments.
