Mayor Meyers welcomed Councilmember Rene Heinrich back to City Council.

- Ordinances First Reading
 - Ordinance 07-2023: An ordinance amending the City's pay classifications ordinance for all employees and various city board member by adding the position of Assistant Police Chief.
 - Action Taken: Member Heinrich made a motion to read ordinance 08-2023 in summary. Seconded by Member Bramel. Discussion: None. Ayes: All. Mayor Meyers declared the motion passed.
 - Ordinance 08-2023: An ordinance enacting the "Smoke-Free Air Ordinance" that prohibits smoking in certain places open to the public, places of employment, and certain public places in the City of Highland Heights, Kentucky.
 - **Discussion**: Violations of the smoke free air ordinance can be cited as a misdemeanor and it seems harsh.
- Update on Greenspace committee.
- Financing of the Bramble Avenue sidewalk was discussed. Also discussed was
 installing sidewalks throughout the city, including creating a year's long plan for
 installation as part of the comprehensive plan. Additionally, creating a plan for
 financing the installation of sidewalks was discussed. Councilmembers Ball and
 Bramel will work with City Administrator Giffen on these plans.
- Discussion of burying electrical, cable, etc. lines underground.
- Police Chief Bill Birkenhauer
 - Speed tracking devices have been purchased that register vehicle speed and time of day. This helps police determine when speeding is occurring so they can have officers with radar guns stop and cite people speeding.
- City Clerk/Treasurer Jeanne Pettit
 - SB141, passed this legislative session which permits code enforcement liens to be place separately on the property tax bill. It also states that these liens cannot be part of the tax liability.
- Code Enforcement Officer Will Hunt
 - Update on code violations and the purchase of iWorq, a web-based code enforcement software.
- Public Works Supervisor Steve Lehman
 - The City Clean-Up event was a success; flag poles at the city sign will be relocated in the next 6 weeks; review of upcoming events.
- Attorney Michelle Eviston
 - Ordinance First Reading
 - Ordinance 09-2023: An ordinance accepting Highland Meadows Drive as a public street in the City of Highland Heights, Kentucky.
