

Clerk/Treasurer Report December 1, 2020

- On November 18, 185 delinquent tax notices were sent to residents who have not paid their property tax and businesses who haven't paid their tangible taxes. We have received approximately 60 payments in response to the notices.

 We are in the process of hiring someone to fill her position. Sue will be greatly missed. She has helped me immensely in transitioning into the City Clerk position and has been an amazing asset to the City during her tenure.
 I want to thank Sue for all she has done to support the City and the Administration Department.

CITY OF HIGHLAND HEIGHTS CITY ENGINEER/ZONING ADMINISTRATOR REPORT

December 1, 2020

ZONING CODE ENFORCEMENT – The vacant/dilapidated house on Rose Avenue is being repaired and should be finished by spring. The vacant houses on Crestwood and on Renshaw have been turned over to the City Attorney so he can request foreclosure action (these have been delayed as the Covid prevents foreclosure on any house that is occupied, and the City Attorney is attempting to get these moving forward as they are vacant).

ABATEMENT ORDINANCE – There are several property owners that are not cleaning up their property – even after they have received multiple fines they are not cleaning the property in a timely manner. Currently I am limited to writing citations and placing liens on the property for any unpaid citations. This is not an ideal situation as several properties remain a burden on the community, and the time spent on writing unpaid citations is not productive. The City of Highland Heights has initiated foreclosure on several properties that are vacant – but we are reluctant to do that on a house that is occupied. Most violations occur on properties that are owned by people who are on a fixed or low income.

The City Attorney has drafted an "ABATEMENT ORDINANCE" that would provide a way for the City of Highland Heights to go onto the property and correct the violation if the property owner does not respond to the enforcement action and fails to correct the violation after being provided a reasonable amount of time. The cost of the cleanup would be paid by the property owner.

ZONING ORDINANCE TEXT AMMENDMENTS – The Planning Commission has forwarded proposed text amendments to Zoning Ordinance for review and approval by City Council. These text changes are requested to:

- Update the ordinance for more current language
- Make changes to signage to eliminate restrictions on sign content
- Add more "current" uses to the Commercial zones
- Provide better definitions where language was previously confusing or incomplete.
- Provide more control over outdoor storage
