

S.I.R.T. SPECIAL INVESTIGATIONS RESPONSE TEAM

On 3/16/22 Newport Police requested The Special Investigation Response Team respond to the 700 block on Ann St where two victims were found inside a house deceased. The initial response included 13 officers from Campbell County Police, Alexandria Police, Cold Spring Police, Highland Heights Police, Wilder Police, Dayton Police and Fort Thomas Police Departments. The SIRT Team was on the scene for over 13 hours where the scene was photographed, FARO Scans were done, evidence was collected and processed. The SIRT Team was able to reconstruct the double homicide scene, determine what item was used as a weapon and use a chemical agent to prove the suspect had cleaned up on the scene. Over the next few days, the Team members completed reports and additional evidence was processed. Newport Police Detectives charged Eric Lightfoot with two counts of Murder.

On 3/27/22 Wilder Police requested The Special Investigation Response Team respond to Bobby Mackey's where three people had been shot after a fight in the parking lot. The initial response included 6 officers from Campbell County Police, Wilder Police, Fort Thomas Police and Highland Heights Police Departments. The SIRT Team was on scene for over 8 hours where the scene was photographed, FARO Scans were done, evidence was collected and processed. Over the next few days, the Team assisted with searching vehicles and each officers completed individual reports. Wilder Police Detectives are still working to present criminal charges as all parties are claiming self-defense for the shooting.





CITY OF HIGHLAND HEIGHTS CITY ENGINEER/ZONING ADMINISTRATOR REPORT

April 5, 2022

ZONING CODE ENFORCEMENT – The Pear trees are in bloom and the grass is beginning to grow. It is likely several weeks before any yards are in violation of the 8" maximum height for vegetation. I did issue 2 citations for outdoor storage recently.

MAIN AVENUE STREET RECONSTRUCTION — We received only 1 bid for the work on Main Avenue on March 28th. TMS Construction submitted a bid of \$327,862 and will start the work in May. My estimate of \$289,625 was prepared several month ago while fuel prices were reasonable — and the TMS proposal is 13% higher.....which is a reasonable increase when you consider the concrete plants how have a \$3 a cubic yard fuel surcharge and all material costs are going up. One contractor who picked up plans said they didn't bid because they were awarded a much larger project in Cincinnati (however he did tell me their bid would have been significantly over \$300,000).

TMS Construction has done work for us before, and the most recent project was the concrete replacement work on Knollwood Drive west of the Ride Hill intersection. They just recently purchased the Krebs Construction property at 130 Main in Highland Heights which is only a couple blocks away from this project.

I recommend accepting the bid and awarding the project to TMS Construction in the amount of \$327, 862.

- We went out 3 times since our March report for snow and/or ice prevention since Feb.23rd.
 We were out for snow events a total of 11.5 hours The events are listed above.
- I am hoping we are finished with snow removal for the season and am including the years report for snow events following:

We have about 120 tons of salt to start out for next winter's snow.

- We spent several days in March filling additional pot holes. I believe we have most of the streets cleared of large potholes except where we have to use hot patch.
- The brick sign is completed at the ball field for the dedication. We are waiting for the sign to be installed.
- New backstop fencing has been installed at the ballfield.
- We spent a couple of weeks cleaning up the ballfield property. We are currently installing
 piping in the large ditch on the south end of the lot so we can place soccer goals that are out
 of the ball field.
- We have another section of the hill that is slipping, south of the first slip. It is about the same size at the first slip. Bray's labor has gone up about \$5.00 per hour, so it will be about \$45,000. This time for repairs
