

CITY OF HIGHLAND HEIGHTS CITY ENGINEER/ZONING ADMINISTRATOR REPORT

June 7, 2022

ZONING CODE ENFORCEMENT – There has been a flurry of enforcement actions over the last few weeks. Many residence and business owners have failed to cut their grass or keep the weeds out of their landscaping. There have also been boat/camper/trailer violations, and a few inoperable/unlicensed vehicle violations. The City has 2-3 properties that are scheduled for an Abatement where the City cleans up the property and invoices the owner for the cost of the cleanup and disposal (the owners were provided plenty of time to correct the violations). initiated in the last few weeks for junk/trash in yards, long grass and inoperable vehicles

MAIN AVENUE STREET RECONSTRUCTION – The work to replace the street and storm sewer began about 3 weeks ago and is going well. The weather is likely the only foreseeable obstacle and dry weather will certainly help progress.

SUNSET AVENUE AND LINCOLN ROAD PAVING – The milling work on Sunset began on June 1st, and paving most likely will be done by the time of this meeting.

SUMMARY AND CONCLUSION – This is most likely my last City Council Meeting for the City of Highland Heights. I first began working for Highland Heights in the late 1980's when I worked with Joe Muhlenkamp to design/bid/inspect the new water and sewer system that served the areas of South Miller, Main, Harrison, Jefferson. I was named the Interim City Engineer in August 1991 and I became the official Engineer for the City in September 1991. My first big project was the design/bidding/inspection of the outfall sewer system that eliminated the sewage pump stations on Knollwood/Hilltop/Ridge Hill and transported the waste to the new sewer line on Pooles Creek Road. The list of the street paving/reconstruction projects that I designed/bid/inspected is long and it includes the water/sewer redesign work for the widening of US 27/Alexandria Pike that occurred in 1994. I believe that Old Alexandria Way and the old section of US 27/Alexandria Pike on the north end of town are likely the only streets that I have not designed and bid any repair work.

In 1999 I became the Zoning Administrator, and as the City Engineer/Zoning administrator I have been involved in the development of Lowes, all the businesses along Martha Layne Collins Boulevard, Klimat Master Pools, Highland Meadows, Highland Ridge, Highland Village, Bluegrass Center, Town Center, General Cable, Frisch's, Gateway West, Stock Yard Bank, Wesbanco, 5th/3Rd Bank, Pet Wow, General Electric Credit Union and the St. Elizabeth Medical Center.

Although the work was sometimes hard and long – I have very much enjoyed serving the residents and business owners in Highland Heights for the past 30+ years. The City employees, Mayor, City Council, Planning Commission and Police Officers are all hard working people dedicated to making Highland Heights the best it can be!
