ORDINANCE NO. 05-2023

AN ORDINANCE AMENDING THE CITY OF HIGHLAND HEIGHTS CODE OF ORDINANCES CHAPTER 31: DEPARTMENTS, BOARDS AND COMMISSIONS

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF HIGHLAND HEIGHTS, KENTUCKY AS FOLLOWS:

Section I

That Section I of Ordinance No. 410, an Ordinance amending Section III of Ordinance 391, which was also an ordinance amending Section III of Ordinance No. 346, duly passed by the Board of Council of the City of Highland Heights, Kentucky, on March 9, 1972, shall be amended as follows:

The Planning Commission shall consist of eight (8) members, ~~seven (7)~~ all of whom shall be citizens and residents of this city, ~~and the remaining one (1) shall be a members of the City Council of the City of Highland Heights, Kentucky, as a member ex-officio.~~ All members of the Planning Commission shall ~~serve, as such, without compensation~~ receive minimum compensation as follows: the Chair shall receive a minimum of \$175 per meeting and Commissioners shall receive a minimum of \$125 per meeting. Compensation is subject to change per approval by Council. ~~However, Additionally, the Planning Commission may incur such reasonable expenses as may be necessary to accomplish the purposes herein, subject to the approval of the Board of Council of the City of Highland Heights, Kentucky.~~

Section II

City of Highland Heights Ordinances Chapter 31 is amended to add a new sub-section regarding the membership of the Planning and Zoning Commission as addressed in Section I:

Section 31.26: MEMBERSHIP

The Planning Commission shall consist of eight (8) members all of whom shall be citizens and residents of this city. All members of the Planning Commission shall receive minimum compensation as follows: the Chair shall receive a minimum of \$175 per meeting and Commissioners shall receive a minimum of \$125 per meeting. Compensation is subject to change per approval by Council. Additionally, the Planning Commission may incur such reasonable expenses as may be necessary to accomplish the purposes herein, subject to the approval of Council.

Section III

The provisions of this Ordinance are hereby declared to be severable, and if any section, phrase or provision, shall for any reason be declared unconstitutional or invalid, such declaration of invalidity shall not affect the validity of the remainder of this Ordinance.

Section IV

All prior resolutions, orders or ordinances or parts of any resolution, order or ordinance in conflict herewith are hereby repealed.

Section V


That this Ordinance shall be signed by the Mayor, attested by the City Clerk/Treasurer and recorded. Same shall be in effect at the earliest time provided by law.
