- Ms. Minter reviewed changes to Articles 8, 11, and 14. Article 10 added Section 10.23 Institutional Zone (INST).
- Changes and Additions:
  - Article 8 Establishment of Zones. Institutional Zone (INST) is added.
  - Article 11 Fences, Walls, and Obstruction to View Regulations. INST requirements would match Residential Zones.
  - Article 14 Sign Regulations. INST are included in the regulations for Commercial/Retail and Office Buildings.
  - Article 10 Zoning Districts. Section 10.23 is added to include Institutional Zone (INST). The Purpose, Uses Permitted, Accessory Uses, Conditional Uses, Area and Height Regulations, and Other Developmental Controls were discussed in detail.
  - Changes to Recommended Text:
    - A. Uses Permitted. Item 7 Strike "and homes for the Aged" from the list.
    - B. Accessory Uses. Item 4 Add "Child Care Facility."
    - C. Conditional Uses. Item 1 Change wording to "Dwelling units for the owner/operator, resident manager, residential staff, or employees when the primary use involves an onsite workforce."
    - D. Area and Height Regulations. Items 4 and 5 Increase Side Yard and Rear Yard Depth to 50 feet.
  - Action Taken: Commissioner White made a motion to table PZ-23-038 to give legal counsel time to review and edit the document. Seconded by Commissioner McNabb. Discussion: None.
  - Roll Call: Commissioners Krebs, yes; McNabb, yes; Chairperson Crawford, yes; Commissioners Koester, yes; White, yes. Chairperson Crawford declared the motion passed.
