### CITY OF HIGHLAND HEIGHTS, KY COUNCIL MINUTES JULY 17, 2018

On Tuesday, July 17, 2018 Mayor Meyers called the Council meeting to order at 176 Johns Hill Road at 7:30 p.m.

**PRESENT:** Mayor Meyers, Council Members: Deborah Ball, Gary Chinn, John Hoffert, AJ Moermond, Jeanne Pettit, Dave Ramler. A quorum was present.

Also present: City Attorney Steve Franzen Jean A. Rauf, City Clerk/Treasurer and Steve Lehman, Public Works Supervisor.

**ABSENT:** Dave Whitacre.

**PRAYER/PLEDGE OF ALLEGIANCE TO THE FLAG:** After Councilmember Ball delivered the prayer, everyone said the pledge of allegiance to the flag.

PRESENTATION OF MINUTES - COUNCIL MINUTES OF JUNE 19, 2018: These minutes had been previous e-mailed to the Mayor, Councilmembers and City Staff for review.

ACTION TAKEN: MEMBER HOFFERT MOVED TO APPROVE THE COUNCIL MINUTES OF JUNE 19, 2018, SECONDED BY MEMBER BALL. DISCUSSION: NONE. AYES: ALL. MOTION PASSED. MAYOR MEYERS DECLARED THE MOTION PASSED UNANIMOUSLY.

**ANNOUNCEMENT:** Mayor Meyers announced that due to the cancellation of the July 3<sup>rd</sup> Council meeting, this meeting is a combination of the July 3<sup>rd</sup> and July 17<sup>th</sup> meetings.

**SCHEDULED GUEST/S: Adam Branscomb, Fairmount Properties:** Mr. Branscomb gave an overhead presentation of Fairmount Properties updates on the new facility. The updates covered the analysis of original master plan, preliminary construction plan, construction access point, construction parking, to keeping the lines of communications open.

Mr. Branscomb reported that the demolition of the five houses and commercial building is scheduled to begin the end of August or the first of September.

Mr. Branscomb further reported that they have been working with the Mayor and team, and NKU on the hours of construction. He reported that during the week work will begin at 7:00 a.m. until 6:00 p.m. with the ability to do some work on Saturdays. Member Pettit asked Mr. Branscomb what time would the work on Saturdays begin. He stated they would begin at 8:00 a.m.

Councilmembers asked several questions that dealt with delays of the demolition because of funding, the traffic study, access for construction, turn lanes off US27, buffers on Faren, access to Medical Building, to the height of the underground garage. All questions were addressed by Mr. Branscomb.
