Mr. Crawford thanked the Planning and Zoning Commissioners and the Board of Adjustment Commissioners for their time and dedication to the City.

Mr. Greg Braun stated he is here with his parents Rita and John Braun about a drainage problem on Clearview Drive. He stated they are asking for assistance with this problem. He stated that he thinks this is due to the installation of the round-about and a drain that was put in on the south side of Johns Hill Road. **OUTCOME:** Mr. Whitacre stated he has done some research on this and has not reached a conclusion. He reported he would again check on this.

There being no further business **MEMBER MOERMOND MOVED TO ADJOURN THE MEETING, SECONDED BY MEMBER HERFURTH. AYE, ALL. MAYOR MEYERS DECLARED THE MOTION PASSED UNANIMOUSLY.**
