 - Development of 3 broad concepts based on infrastructure and community input:
 - Play and Adventure
 - Gather and Create
 - Discover and Explore
- Preferred concepts, recommended implementation phases, and the cost for each phase grew from the broad concepts. Working name: The Commons at Highland Heights.
 - Phase A Greenway Commons Connect upper and lower greenspaces with art and a rest area along the way. Cost: \$1,203,008.
 - Phase B Central Commons Create an activity plaza for adults; develop the hillside overlook and add benches; pickleball courts. Cost: \$962,600.
 - Phase C Community Commons Expand playground and include an ADA accessible play space for children; performing arts/multi-use pavilion. Cost: \$1,820,037.
 - Phase D Recreational Commons Active courts and gathering areas. Cost: \$665,258.
 - Total cost: \$4,650,902
